For your convenience, if forms are mailed or paid online by Monday, August 20th, your student's bus pass will be delivered to their campus by the first day of school. Students will be allowed to ride the bus to school and pick up their pass at their campus. Any bus pass transactions received after August 20th will be processed and passes delivered to the campus.
